(1) As reported in a Schedule 13G filed by EchoStar Communications Corporation, a Nevada corporation (currently known as DISH Network Corporation, "DISH"), with the Securities and Exchange Commission on December 19, 2005, DISH beneficially owned an aggregate of 1,350,532 shares of voting common stock ("Shares") of Loral Space & Communications Inc., a Delaware corporation (the "Issuer") as of the time of such filing, including Shares issued to DISH on December 9, 2005 in connection with the Fourth Amended Joint Plan of Reorganization under Chapter 11 of the United States Bankruptcy Code, as modified, of Loral Space & Communications Ltd., a Bermuda company ("Old Loral"), and certain of its subsidiaries (the "Plan"). DISH also received an aggregate of 122,163 Shares that were distributed subsequently from time to time under the Plan in connection with the resolution of certain remaining claims against Old Loral.

Effective January 1, 2008, DISH completed its distribution to EchoStar Corporation, a Nevada corporation ("EchoStar"), of its digital set-top box business and certain infrastructure and other assets, including certain of its satellites, uplink and satellite transmission assets, real estate and other assets and related liabilities (such transaction, the "Spin-off"). Since the Spin-off, DISH and EchoStar have operated as separate publiclytraded companies and neither entity has any ownership interest in the other. A substantial majority of the voting power of the shares of DISH and EchoStar is owned beneficially by Charles W. Ergen or by certain trusts established by Mr. Ergen for the benefit of his family. All Shares of the Issuer previously held by DISH were transferred to EchoStar in connection with and as a result of the Spin-off, with DISH beneficially owning no Share of the Issuer thereafter.
