

Major Latin America Operator Expands GSM and WiMAX Services With Hughes Satellite Network Technology

Employing a highly efficient dynamic bandwidth allocation protocol, and with very low traffic latency and jitter, the HX System delivers both excellent voice quality and high data throughputs.
