Explanation of Responses:

1. On November 30, 2018, Charles W. Ergen established the Ergen Two-Year November 2018 DISH GRAT (the "Two-Year November 2018 DISH GRAT") and contributed 50,000,000 Class B shares to the Two-Year November 2018 DISH GRAT. The Two-Year November 2018 DISH GRAT may elect to convert any or all of its Class B shares into an equal number of Class A shares at any time for no additional consideration. The Two-Year November 2018 DISH GRAT is scheduled to expire in accordance with its terms on November 30, 2020. Mrs. Cantey M. Ergen serves as the trustee of such GRAT.

2. Pursuant to the terms of the Two-Year November 2018 DISH GRAT, 23,037,365 Class B shares were distributed as an annuity to Mr. Ergen on December 2, 2019. Following this distribution, the Two-Year November 2018 DISH GRAT retained 26,962,635 Class B shares.
